**MEMBER FEES AND EXPENSES**

MEMBER FEES SHALL BE AS SPECIFIED IN EACH "CSP MEMBER AGREEMENT".  
MEMBER EXPENSES SHALL BE AS SPECIFIED IN THE "CDRS FEES AND COSTS SCHEDULE" AS LISTED ON THE CDRS WEBSITE.

**ADR PROCESS FEES**

THE FEES FOR A CSP ADVISORY OPINION, SPECIALIST TESTIMONY OR ADVICE, MEDIATION, ARBITRATION OR OTHER ADR PROCESS SHALL BE AS SPECIFIED IN THE "CSP MEMBER AGREEMENT" FOR SERVICES RENDERED. THERE SHALL BE NO OTHER ADMINISTRATIVE OR RELATED FEES FOR A CSP ADR PROCESS OTHER THAN THE HOURLY FEES AND ADMINISTRATIVE FEES AS SPECIFIED ABOVE. CDRS ADMINISTRATIVE FEES ARE INCLUDED IN THE MEMBER FEE AS SPECIFIED IN THE "CSP MEMBER AGREEMENT".

**TERMS AND CONDITIONS**

ALL FEES AND COSTS FROM CDRS OR FOR THE SERVICES AND/OR EXPENSES OF A CSP MEMBER SHALL BE BILLED BY CDRS. PAYMENTS TO CDRS SHALL BE DUE 15 DAYS FROM THE DATE OF THE CDRS INVOICE. IF PAYMENTS ARE NOT MADE ACCORDING TO THESE TERMS, CDRS RESERVES THE RIGHT TO DISCONTINUE OR SUSPEND ANY OF THE ACTIVITIES OF THE CSP UNTIL PAYMENT HAS BEEN RECEIVED. CDRS RESERVES THE RIGHT TO CHANGE THE PAYMENT TERMS AND CONDITIONS OF THE CSP IF THE SPECIFIED TERMS AND CONDITIONS ARE NOT FOLLOWED.
